REQUIREMENTS FOR COURSE ENROLLMENT

- 1. Foreign valid and current CPL (A) or ATPL (A) license issued by ICAO contracting state.
- 2. Copy of the foreign medical certificate.
- 3. A copy of the pilot log book authenticated by U.A.E operator; GCAA may accept an authenticating conducted by a U.A.E ATO.
- 4. License Verification from the issuing authority verifies the details of the license.
- 5. GCAA Class 1 Medical Certificate.
- 6. GCAA approved ELP
