The course will be set up as per the pilot experience and the type rating as following:

REQUIREMENTS FOR COURSE ENROLLMENT

1. Foreign valid and current CPL (A) license issued by ICAO contracting state.
2. Copy of the foreign medical certificate.
3. A copy of the pilot log book authenticated by U.A.E operator; GCAA may accept an authenticating conducted by a U.A.E ATO.
4. License Verification from the issuing authority verifies the details of the license.
5. GCAA Class 1 Medical Certificate.
6. GCAA approved ELP
7. UAE Valid Resident Visa

COURSE DURATION

The duration of the course

- 1- **2 weeks with experience.**
- 2- **4 weeks with experience.**

COURSE FEES

1. **A- With flight experience: AED 12,500.00 – (AED Twelve Thousand Five Hundred Only) + UAE VAT.**
B- Without flight experience: AED 21,000.00 – (AED Twenty-One Thousand Only) +UAE VAT.
2. **A-CPL IR with experience: AED 14,500.00–(AED Fourteen Thousand Five Hundred Only)+UAE VAT.**
B- CPL IR without experience AED 23,000.00 – (AED Twenty-Three Thousand Only) +UAE VAT.

COURSE FEES INCLUDE

1. Training Materials.
2. Theoretical Knowledge (**Exams**).
3. Type technical (Theoretical knowledge- 5hrs)
4. Internal exams (Two attempts for each subject)
5. GCAA exam fees (One attempt for each subject)
6. Single Engine VFR Flight Training -4hrs and skill test-1.5hr.

PAYMENT SCHEDULE

1. 50% is to be paid prior to start the course
2. The reaming is to be paid prior to start the flying training.

3. ELP Test.
4. Designated Examiners' for Skill Tests.
5. GCAA exam fees for any failed subject.
6. Internal exams for any failed exam beyond two attempts.

EXTRA FLIGHT TRAINING RATE
